My Orders are as follows:

- i) Revert all Property back to the private, sole and exclusive Owner, Dean Clifford, immediately and without delay.

- 2) The private man, Dean C. Clifford, is to be set free immediately and without delay. There will be no re-lease as he is the Rightful Owner and does not lose anything from Her Majesty.
- 3) Deposit all original issue documents into public record No. CR 14-01-33786 so that the Declaration is a matter of public record.
- 4) All Warrants are Overruled and Revoked by this duly authorized General Executor, the highest office on the land.
- 5) All charges authorized by the de facto Attorney General for Manitoba are hereby Overruled and Revoked, Denied, by the lawful and duly authorized General Executor. You, the Trustee, are Ordered to discharge the entire matter.
- 6) All power of attorney and especially general power of attorney claimed and presumed by the Attorney General for Manitoba is revoked and specifically denied, the Attorney General for Manitoba was never granted general power of attorney, that is fraud.
- 7) You possess a live ink signature original issue Will of the Rightful Owner in the file, you are

instructed to execute the Will immediately and without delay.

- 8.) You possess an original issue Commercial Lien in the file, you are instructed to execute the Commercial Lien immediately and without delay. You are to immediately seize all bonds and securities listed in the Collateral Schedule as the Owner, Dean C. Clifford, owns all equity in the Account/File No. CR-14-01-33786
- 9.) Execute all bonds underwriting the charges.
- 10.) Send all court stamped copies of all deposited documents to the Office of General Executor.

Declaration of Secession and Independence

I, a man, Dean-Christopher-David of the House of Clifford, born in the flesh on the ninth day of the month of June in the year of my Lord nineteen-hundred-seventy-five at the city of Winnipeg, Manitoba province, landmass of Canada, son of David Clifford and Donna Wakefield, a child of the one true God, as the Rightful Heir and Rightful Owner of my Life and all property in my name do Declare the following facts to be true to the best of my ability and belief as God is my Witness:

Whereas I was born a free and sovereign individual subject to no other of mankind or any other earthly authority and remain so in perpetuity until death;

And Whereas I have never knowingly, willingly or with informed consent or intent pledged or promised my Life, Liberty or Property to another;

And Whereas I have the natural Right to be free-willed, independent, self-governing and self-determining and do claim and fully reserve all such Rights;

And Whereas I have the Right to not be forced into service, servitude, association, union, incorporation or any other form of allegiance, slavery or subjugation;

And Whereas I have made my free-will very clear to Her Majesty the Queen to be left alone to live in peace and to govern my own affairs;

And Whereas Her Majesty the Queen has refused to leave me alone to govern my own Life in accordance with my own free-will under God;

And Whereas the Will of the Owner is the Law;

And Whereas I have the sole natural Right to make any Law I Wish regarding my Life and Property;

And Whereas Her Majesty the Queen refuses to respect my Will, my Wishes and my natural Property Rights;

And Whereas Her Majesty the Queen has repeatedly and intentionally trespassed against me and my Property to unjustly enrich her institutions;

And Whereas Her Majesty the Queen has repeatedly and intentionally used acts of armed naked aggression to steal my Property and deprive me of its use;

And Whereas Her Majesty the Queen has repeatedly and intentionally used acts of armed naked aggression to assault and kidnap me, confine me arbitrarily in a torture chamber for up to sixteen months and subject me

to every indignity imaginable contrary to the inherent worth of a man;

And Whereas Her Majesty the Queen has repeatedly and intentionally used acts of armed naked aggression to carry out unconscionable acts of terrorism against me to force her will on me contrary to my own free-will for the unjust enrichment of her institutions and to my express detriment and loss;

And Whereas Her Majesty the Queen holds Property in Trust in my name, being the share of my Birthright to this land, and has repeatedly and intentionally deceived me, misled me, coerced me, threatened me and concealed from me access to my Birthright for my benefit but has instead administrated Trust Property for the unjust enrichment of her institutions and to my express loss and detriment;

And Whereas Her Majesty the Queen has repeatedly and intentionally carried out and committed breaches of trust in the nature of treason;

And Whereas Her Majesty the Queen has repeatedly and intentionally denied me my own free-will and natural Rights to enforce her will through force of arms and outright naked aggression to subjugate me, a free people;

And Whereas Her Majesty the Queen has forced her
very unwanted institutions and services on me, a free
people of this land, and has acted in bad faith and
in dishonour in every instance;

And Whereas Her Majesty the Queen has endeavored
to conceal, mislead, coerce, deceive and threaten a
free people to deny me my natural Rights to Life, Liberty
and Property;

And Whereas Her Majesty the Queen has permanently
stationed armed, immoral, violent, poorly trained,
aggressive and hopelessly corrupt agents and officers
throughout this land to incessantly harass and attack
any man, especially myself, who would choose to be a
free and independent people not subject to the foreign
institutions of Her Majesty the Queen;

And Whereas Her Majesty the Queen has permanently
stationed armed forces throughout this land who have
been used to attack any free people who wish to reclaim
their stolen birthright from her institutions;

And Whereas Her Majesty the Queen accepted a fiduciary
duty and gave an Oath to the people and to God to
protect their natural Rights and birthright to this land
as Trustee and has violated that sacred Oath and
Promise at every instance;

And Whereas Her Majesty the Queen has denied remedy to me through endless litigation in corrupt courts with armies of lawyers, superior knowledge of law, limitless access to my stolen credit and resources and armies of officials who never question any order they are given no matter how lawless or inherently wrong;

And Whereas Her Majesty the Queen has connived and conspired to deprive me of my Life, Liberty and Property and to deprive me of any meaningful existence and happiness and has caused irreparable harm to my Life that cannot be fixed or adequately remedied;

And Whereas Her Majesty the Queen has tortured me for four hundred and seventy two days in a torture facility where I have been deprived of my Life, my dignity, proper food of my choosing, sanitation, my Property, my family, sunlight, happiness, my free-will, nature, fresh air and every other inherent Right I possess as a man for doing nothing more than refusing to be subject to the will of her foreign institutions while harming no one;

And Whereas Her Majesty the Queen has repeatedly and intentionally used force of arms and naked aggression to subjugate me under the guise of fake, non-existent, unilateral and imposed contracts that cannot be challenged or questioned in her courts;

And Whereas Her Majesty the Queen repeatedly and intentionally uses the doctrine of 'might makes right' in order to impose her will and institutions on me for her continued unjust enrichment;

And Whereas Her Majesty the Queen is a de facto, foreign, terrorist regime that imposes its 'services' and will on the people of this land without their informed consent;

And Whereas Her Majesty the Queen has been given notice many times of my Will and Wish to be independent, free, self-determining and to not be a party or member of her foreign institutions;

And Whereas Her Majesty the Queen has then attacked me in violation of natural law, international law, the Laws of God and her own Oath and Promise as Trustee;

And Whereas Her Majesty the Queen has abused her position of Trustee and imposed her own will to deprive me, the Rightful Owner, of everything held in Trust, being a breach of trust in the nature of treason;

And Whereas Her Majesty the Queen has unceasingly harassed me and attacked me under force of arms for my refusal to contract with her unwanted, useless, expensive, purposeless and property stealing foreign institutions;

And Whereas Her Majesty the Queen has no right or claim to this land or the people of this land;

And Whereas Her Majesty the Queen is a foreign, de facto, forcefully imposed, criminal and terrorist organization that does not respect any rule of law or inherent Right of a man;

And Whereas Her Majesty the Queen refuses to recognize me as the Rightful Owner of my Private Property and respect my Will regarding my Property while continuing unabated to administrate her will without right;

And Whereas Her Majesty the Queen has no right to rule over me or to force me to be a party to her democratic society of Canada but has done so regardless;

And Whereas Her Majesty the Queen has no right to steal my Property and my resources but has done so regardless;

And Whereas Her Majesty the Queen has repeatedly and intentionally attacked my private business in favour of her own institutions and protected monopolies for her benefit and unjust enrichment;

And Whereas Her Majesty the Queen has repeatedly and intentionally attacked me for wishing to live in peace and minding my own business and refusing to do business

with her institutions;

And whereas the institutions of Her Majesty the Queen are so corrupt, useless, burdensome, expensive and completely unnecessary that no one in their right mind would willingly do business with them unless forced to at gun-point, literally;

And whereas Her Majesty the Queen has no right to force me into any form of dealings with her foreign institutions;

And whereas on at least five occasions since 2005 I have been waylaid on my own highways by officers acting as Her Majesty the Queen under force of arms who have stolen my work trucks and work tools in the name of Her Majesty, totalling over \$80,000.00, and never had any returned despite repeated demands;

And whereas in November of 2013 many armed officers acting as Her Majesty did invade my private home and did steal private property, did violate the sanctity of my private sanctuary and did violate my private office and my private papers and files;

And whereas more of my Property is owned collectively by any institution of Her Majesty but is exclusive Private Property for my own private use;

And Whereas Her Majesty the Queen repeatedly and intentionally continues to steal what it has no right or claim to under force of arms;

And Whereas Her Majesty the Queen repeatedly and intentionally attempts to force me and my Private Property into their collective democratic society of Canada to impose their will on me and my Private - Property;

And Whereas I have and continue to reject the collective democratic society of Canada and the will of their foreign society;

And Whereas I have the right to be private, free, unaffiliated and unincorporated into their democratic collective;

And Whereas I have prohibited the democratic society of Canada from administrating both my Life and my Private - Property;

And Whereas Her Majesty the Queen has no right to administrate a foreign will against me or my Private - Property or to meddle in my affairs;

And Whereas I am the lawful government of my Birthright and my Property;

And Whereas I was born in the flesh on this land
and I am the Rightful Crown by Birthright of all
Property for which I am the Rightful Owner;

And Whereas I am the Rightful Crown no agent or
officer of Her Majesty the Queen represents me as I
reject her institutions wholly and outright;

And Whereas I have revoked, overruled and denied
any and all presumed, assumed and mistakenly
expressed power of attorney that Her Majesty the Queen
falsely claims or believes it too;

And Whereas I am the Rightful Owner, the Crown,
the Will, the source of Law, the Head of State, the
Executor, the Governor General and the Attorney General
in all matters relating to my Life and Private-Property;

And Whereas my Will is His Will;

Therefore, due to these and many other injustices and
indignities that are insufferable for which I have been
repeatedly subjected to I hereby formally sever all ties
with Her Majesty the Queen;

And That I demand satisfaction, restitution and relief
for all the wrong doing, indignities, thefts and damages
caused by Her Majesty the Queen;

And That I require Her Majesty the Queen to immediately and without delay cease all unwarranted, unauthorized and prohibited actions against me and my Private Property;

And That I require the immediate return of all Property held by Her Majesty the Queen in my name;

And That I require Her Majesty the Queen to cease all contact with me with exception to mailing me my quarterly cheque for all my Royalties due on my resources, in full with no deductions for any services;

And That Her Majesty the Queen is required to restore me immediately and without delay.

The Will of the Owner is the Law. My Word is my Will, so it is written so it shall be done.

We three good men of the age of majority bear witness to the signing of this Declaration. This man is known to us and we regard him as an honourable man.

PUBLIC ORDER OF REVOCATION
**NULLIFYING THE LEGAL AUTHORITY OF THE CROWN OF
ENGLAND AND ITS GOVERNMENTS**

**THIS ORDER IS ISSUED TO ALL AGENTS AND OFFICERS OF THE
CROWN OF ENGLAND BY THE PEOPLE ASSEMBLED IN COMMON
LAW COVENANT**

LET IT BE KNOWN that as of today, the First Day of March, 2013, you are obligated under the law to **STAND DOWN** from your oath of office and duty towards the Crown of England and its fiduciary head Elizabeth Windsor *aka 'Queen of England'*, whose legal authority has been forever revoked and nullified by a lawful verdict of the International Common Law Court of Justice that found them guilty of Crimes against Humanity. (*Case docket 02252013-001, reverse*)

LET IT BE FURTHER KNOWN that if you disregard this **ORDER OF REVOCATION** and do not immediately stand down from your office as an agent of the criminal body known as the Crown of England, you will be considered and declared to be colluding with this Body Corporate and person in their proven crimes and Treason against the People, and you will be subject to arrest and imprisonment.

This **ORDER** applies to all peace officers, soldiers, judges, civil servants, politicians and other agents of the Crown of England within the governments and courts of England, Canada, Australia, New Zealand and all other commonwealth nations.

This ORDER is issued by the International Common Law Court of Justice and its authority under Natural Law and according to the Will of the People as the Sovereign Head and Source of all government, today, March 1, 2013.


Decision of the Court In the Matter of The People v. Eizabeth Windsor, Joseph Ratzinger et al, and their Bodies Corporate, The Crown of England and The Church of Rome

It is the unanimous verdict of this Court that the thirty defendants and their Bodies Corporate named in the principal indictment are guilty as charged of committing and concealing Crimes against Humanity, Genocide, and Wars of Aggression against the People, their children, and their Liberties, and of thereby subverting the laws of the Commons and of God.

These convicted persons and bodies are thereby sentenced to immediate arrest and disestablishment, to the loss of their freedom, the forfeiture of their wealth and property, and to the revoking of their authority, laws, statutes and governance. All of their agents and officers are forthwith released from their legal obligation towards these convicted persons and Bodies Corporate, and will stand down from their offices.

Having violated her Coronation Oath to uphold the faith and liberties of the People of the Commonwealth by acting in the interests of a foreign power, namely the Church of Rome, and of thereby committing the treasonable offense of Premunire, the convicted felon Elizabeth Windsor, *aka 'Queen of England'*, is no longer the Head of Church and State in England, Canada or any Commonwealth nation. The former authority of the Crown of England is revoked and nullified, and shall be replaced by Constitutional Republics established by the People in Covenant.

This decision of the Court stands *stare decisis* and carries with it the full effect and enforcement of the Law. Issued on the twenty fifth day of February in the year 2013 in Brussels.

1975.

As God is my Witness, I do claim the following and
make Declaration:

1) I have been redeemed by the blood shed of my Lord
Jesus Christ. I do not possess nor do I, a man of God,
bear a Birth Certificate of Canada. I, a man of God, am
no longer in bondage and I serve the God of the living,
not the dead fictions of law of Canada. I am a righteous
man living in the Spirit, I am a man of faith, I will not
be under bondage and bond a person of Canada, I cannot
be two beings.

2) I was the Grantor and Sole Beneficiary of the above named Cestui-que-vie Trust Account which is neither needed or wanted, I am alive and well and I do not want or require any of your services. I am the Rightful Heir to all property held in Trust. I wish for you to collapse the Trust and restore all property. You have been instructed to do so several times now and you have not. You are harming me. You are forcing me into bondage against my will and against the Will of my Father. All property has been pledged to my own House, completely unaffiliated with the society of Canada, so that I may serve Him. You have no claim or right to my property, a gift from my Father, and in His name I demand that you deliver it unto me immediately and without delay.

2) There should no longer be a Trust Account in that name as I am alive and have claimed my property and my birthright, I live in the Spirit. I wish for the Trust to be collapsed immediately and all property restored. You continue to refuse to recognize me in my true identity to keep and control what does not belong to you and force me into bondage. I wish to leave to serve my Father. I have been serving Him but you continue to trespass and force your will on me over His and I demand in His name that you cease.

1) I am alive, I am a righteous man living in the Spirit, serving the God of the living. I do not live under the law of Canada, I am a man of Faith, a man of God.

5) I am not in bondage, I no longer bond the person of Canada, I have pulled my bonding from the dead person, it is dead. I do not give life to dead fictions of legalese, I am of the living. You are ordered and required, instructed, to issue a Death Certificate for the dead person of Canada as I ceased giving life to it many years ago and I do not ever wish to come back. Let the dead do business with the dead and the living with the living.

6) The society of Canada is trespassing against me, I am being greatly harmed and injured. Your society is foreign to my House and is forcing a false identity on me, forcing their will on me to keep me in bondage and take what does not belong to them by physical violence and force of arms. You and your society are practicing iniquity and slavery. I wish to be released from bondage, I do not consent and I never have consented. I am a Rightful Heir through Jesus Christ, I am of Him and of His Kingdom, not the society of Canada, I have made my choice.

7) In October of the year of our Lord two-thousand-thirteen I entered into Holy Union with my Wife, Breanne-Jeanne, and we both pledged our lives to one another and our new family, the House of Clifford, and pledged our lives to serve our true Master, YHWH, and our Lord Christ. The Constitution of our House is His Will, the Holy Bible. You have no record of this Union because the society of Canada nor Her Majesty were a party to it and we wish to have nothing to do with the society.

of Canada nor Her Majesty and their re-constitution of what really belongs to Him. My Wife and I wish to have nothing to do with pagans, idolaters and lawless men of no faith who practice iniquity. We wish to be left alone to serve Him.

8.) My Brother, Daven - Munay - Murphy is also of our House of Clifford and has chosen to serve the Lord and leave your society of lawless, faithless pagans. My Brother, Daven, also speaks for our House, which is completely unaffiliated to the society of Canada, and he has also pledged his life and property to our House in the service of the one true God under His Constitution.


9.) If your society of Canada is claiming to have any equitable interest or equitable claim of any kind to the man of God called Dean - Christopher - David of the House of Clifford of the Kingdom of God, born a living Spirit on June the ninth in the year of our Lord ~~two~~ ~~thousand~~ ~~and~~ ~~seventy~~ ~~five~~ ~~hundred~~ ~~and~~ ~~seventy~~ ~~five~~, then you are hereby commanded in the name of my Father to produce empirical proof of claim to his body, life and property within ten (10) days of ^{DC} ~~the~~ ^{filling} ~~the~~ of this Notice or you abandon and relinquish any and all claims for all time and you shall forever hold your peace. You have ten (10) days to produce empirical proof of any claim or you will stand convicted by your silence and guilty of practicing iniquity and forced slavery and forced bondage of a child of God.

10) I prohibit and deny to the society of Canada and Her Majesty the Queen any control or possession of any of my property or birthright. I deny all these institutions any authority to administrate in any way for my House and do command in the name of my Father that all parties cease trespassing immediately. ~~[I will forgive all trespasses against me to date if all parties will cease their actions.]~~ restore all property and release me from their forced bondage. None of you have any claim to me and you are harming me.

11) I deny any and all claims against me by the society of Canada and Her Majesty, they have no claim to me. I have done no wrong and I have broken no agreements.

Again, I am a man redeemed by the shed blood of Jesus Christ, in the living Spirit, a man of faith, a righteous man and in the name of my Father and with His Authority I require you to release me, restore all property and to cease your trespasses. Thy Will be done on earth, as it is in heaven.
