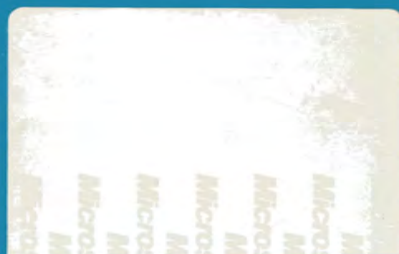

## INTRODUCTION

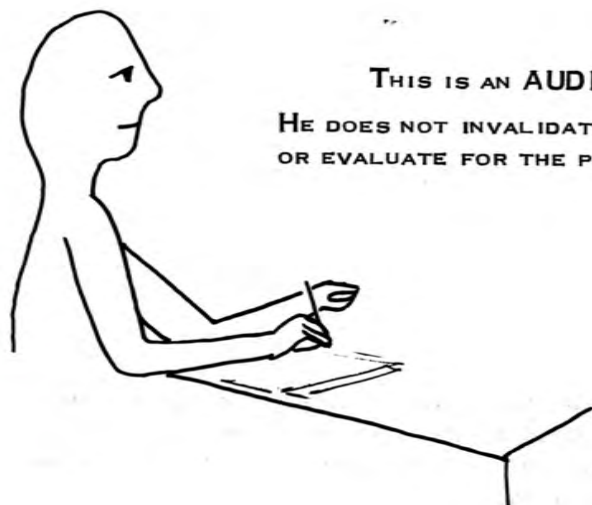

WE CONGRATULATE YOU FOR BEING SUCH A SPECIAL PERSON.

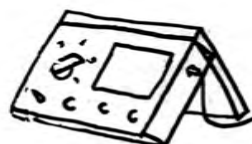

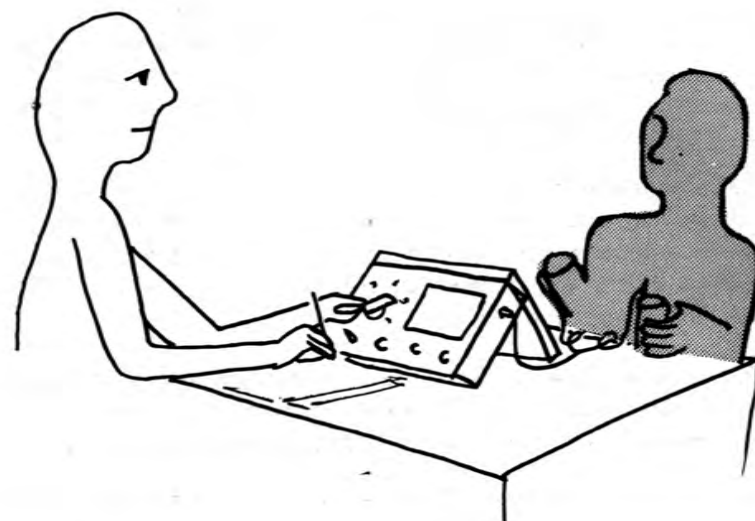

## KNOW HOW THE MIND WORKS

THE MORE YOU KNOW ABOUT THE MIND AND HOW IT WORKS, THE MORE SMOOTHLY AND QUICKLY YOU WILL MOVE ALONG IN YOUR AUDITING.

PRIOR TO YOUR FIRST AUDITING, YOU WILL TAKE THE PERSONAL EFFICIENCY (PE) COURSE AND THE COMMUNICATION COURSE. WE ALSO RECOMMEND THAT YOU READ THE BOOK, DIANETICS: THE MODERN SCIENCE OF MENTAL HEALTH BY L. RON HUBBARD.

BEFORE EACH STEP OF AUDITING BEGINS, YOU MUST UNDERSTAND THE WORDS RELATED TO THE PROCESSES TO BE RUN. THE WORDS YOU NEED TO KNOW FOR YOUR FIRST AUDITING WILL BE FOUND IN THE NEXT SECTION OF THIS BOOK, "ABOUT AUDITING."

AS YOU MAY HAVE LEARNED, A PERSON GOES THROUGH LIFE AUTOMATICALLY "TAKING PICTURES" OF EVERY EXPERIENCE. WE CALL THESE MENTAL IMAGE PICTURES.

IF YOU ASK SOMEONE TO DESCRIBE A FLOWER, HE WOULD ACTUALLY SEE A PICTURE OF A FLOWER IN HIS MIND. HE MIGHT ALSO RECALL THE SCENT AND FEEL OF THE FLOWER AS WELL. THIS IS A MENTAL IMAGE PICTURE.

THIS IS THE ACTUAL CONTENT OF THE MIND. THE MIND IS MENTAL IMAGE PICTURES. SOME CAN BE RECALLED EASILY AND WILLINGLY. HERE IS STORED THE INFORMATION WE HAVE GAINED THROUGH EDUCATION AND EXPERIENCE. WE USE THESE PICTURES TO MAKE DECISIONS AND SOLVE PROBLEMS IN PRESENT TIME. FOR PURPOSES OF DIFFERENTIATION, WE CALL THIS GROUP OF PICTURES THE "ANALYTICAL MIND."

WE ALSO TAKE PICTURES OF EXPERIENCES THAT CONTAIN PAIN AND UNCONSCIOUSNESS, AND THESE ARE CALLED THE "REACTIVE MIND." SINCE THE ANALYTICAL AWARENESS IS SHUT DOWN DURING SUCH MOMENTS, WE DON'T CONSCIOUS-

LY REMEMBER THEM. HOWEVER, THESE HIDDEN PICTURES CAN GET REACTIVATED (OR RESTIMULATED) BY SOMETHING IN OUR PRESENT ENVIRONMENT AND CAUSE EMOTIONAL TURMOIL AND PHYSICAL DISORDERS. NO AMOUNT OF REASONING OR EFFORT WILL PREVENT THESE UPSETTING REACTIONS. ONLY THROUGH AUDITING CAN A PERSON RID HIMSELF OF UNWANTED FEELINGS AND REACTIONS.





## ABOUT AUDITING

"THE ANALYTICAL MIND WHEN IT BECOMES AWARE OF A POINT IN THE REACTIVE MIND, MAKES IT VANISH. IN OTHER WORDS ONE NEEDS BUT BECOME AWARE OF THE ACTUAL CAUSE OF AN ABERRATION TO HAVE IT VANISH." L. RON HUBBARD, HCOB, JUNE 30, 1965

BEFORE YOU BEGIN DIANETIC AUDITING, LEARN THE FOLLOWING WORDS AND THEIR MEANINGS:

**AN ENGRAM** IS A MENTAL IMAGE PICTURE WHICH IS A RECORDING OF A TIME OF PHYSICAL PAIN AND UNCONSCIOUSNESS. IT MUST BY DEFINITION HAVE IMPACT OR INJURY AS PART OF ITS CONTENT.

**A SECONDARY** IS A MENTAL IMAGE PICTURE OF A MOMENT OF SEVERE AND SHOCKING LOSS OR THREAT OF LOSS WHICH CONTAINS MISEMOTION SUCH AS ANGER, FEAR, GRIEF, APATHY OR "DEATHFULNESS."

**A LOCK** IS A MENTAL IMAGE PICTURE OF AN INCIDENT WHERE ONE WAS KNOWINGLY OR UNKNOWINGLY REMINDED OF A SECONDARY OR ENGRAM. IT DOES NOT ITSELF CONTAIN A BLOW OR A BURN OR IMPACT AND IS NOT ANY MAJOR CAUSE OF MISEMOTION. IT DOES NOT CONTAIN UNCONSCIOUSNESS. IT MAY CONTAIN A FEELING OF PAIN OR ILLNESS, BUT IS NOT ITSELF THE SOURCE OF IT. EXAMPLE: ONE SEES A CAKE, FEELS SICK. THIS IS A LOCK ON AN ENGRAM OF BEING MADE SICK BY EATING CAKE. THE PICTURE OF SEEING A CAKE AND FEELING SICK IS A LOCK ON (IS LOCKED TO) THE INCIDENT (UNSEEN AT THE MOMENT) OF GETTING SICK EATING CAKE.

**ERASURE** IS THE ACTION OF ERASING, RUBBING OUT, LOCKS, SECONDARIES OR ENGRAMS.

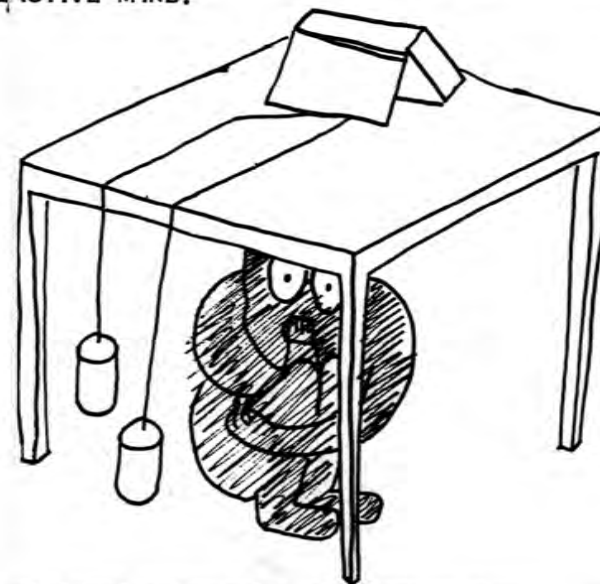
**CHAIN** MEANS A SERIES OF RECORDINGS OF SIMILAR EXPERIENCES. A CHAIN HAS ENGRAMS, SECONDARIES AND LOCKS. EXAMPLE: SEEING A BASEBALL BAT IN A STORE

WINDOW (LOCK), LOSING A BAT (SECONDARY), HIT IN THE HEAD WITH A BAT (ENGRAM). THE ENGRAM IS THE EARLIEST DATE, THE SECONDARY A LATER DATE, THE LOCK THE MOST RECENT.

**GOING SOLID** MEANS INCREASED MASS, INCREASED PRESSURE OR INTENSIFIED SOMATIC. AT TIMES IN A SESSION, THE AUDITOR WILL ASK YOU IF THE INCIDENT IS BECOMING MORE SOLID IN ORDER TO DETERMINE WHETHER OR NOT IT IS ERASING. (IF IT IS GOING MORE SOLID, IT IS NOT ERASING.)

**DIANETIC AUDITING** IS A TECHNOLOGY THAT RUNS CHAINS OF LOCKS, SECONDARIES AND ENGRAMS TO ERASURE. DIANETICS IS ENDED OFF ONLY WHEN THE PRECLEAR HAS BECOME WELL AND HAPPY AND REMAINS THAT WAY.

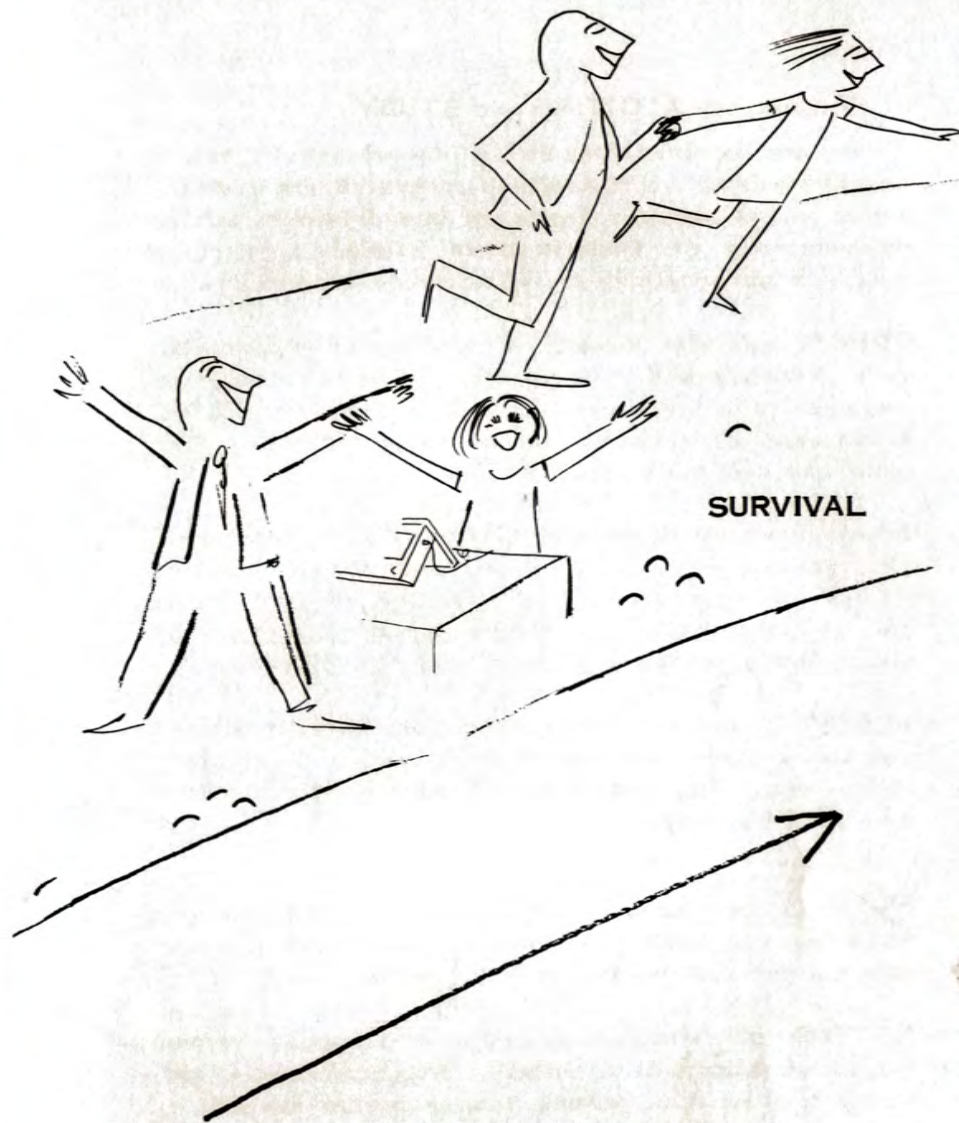
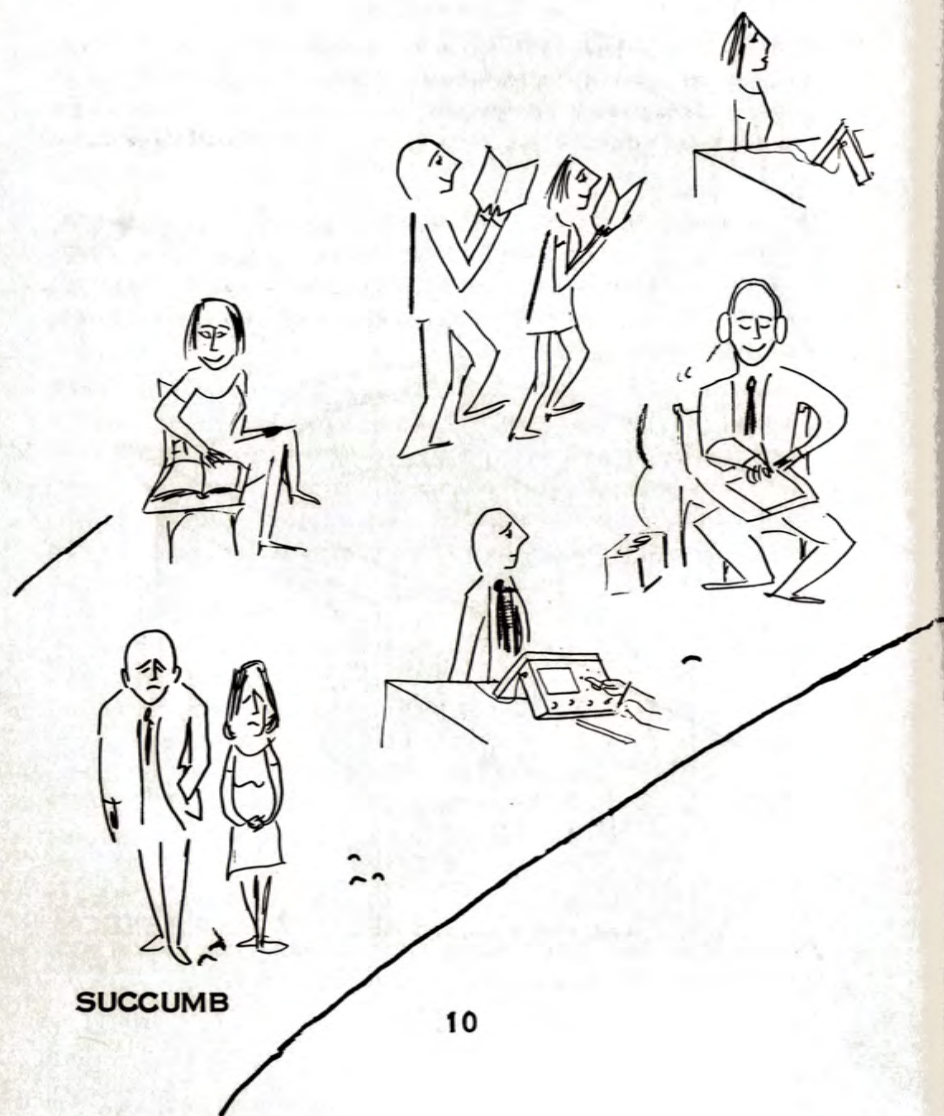
WITH THE ASSISTANCE OF AN AUDITOR AND HIS E-METER, A SESSION IS A PLEASANT EXPERIENCE. SHOULD YOU FEEL FEARFUL ABOUT YOUR FIRST AUDITING SESSION, JUST BE AWARE OF THE FACT THAT THIS EMOTION IS COMING FROM THE REACTIVE MIND.



AFTER AUDITING, PRECLEAR UNDERSTAND (AND LAUGH AT) THEIR FORMER FEARS, PAINS, AND TRAVAILS.

## RULES

THERE ARE SEVERAL "RULES" WHICH WE EXPECT YOU TO OBSERVE DURING YOUR AUDITING INTENSIVE (OR REVIEW). THESE RULES ARE NOT BASED ON OUR OPINIONS, BUT ON OBSERVATIONS OF THOUSANDS OF CASES. A PRECLEAR WILL NOT GET RESULTS IF THESE RULES ARE VIOLATED.

**DRUGS.** DO NOT TAKE DRUGS WHILE BEING AUDITED. THIS INCLUDES SLEEPING PILLS, TRANQUILIZERS, PAIN KILLERS, (INCLUDING ASPIRIN), DIET PILLS, ANTIBIOTICS, SEDATIVES, STIMULANTS, OR OTHER MEDICINES. VITAMINS ARE NOT CONSIDERED DRUGS.

IF YOU HAVE TAKEN ANY DRUG "TRIPS" WITH MARIJUANA, LSD, PEYOTE, DEXEDRINE, OR ANY DRUG WHICH PRODUCES A "HIGH" FEELING OR A "LOW" FEELING, REPORT THIS TO US. YOU MUST WAIT SIX WEEKS AFTER TAKING ANY OF THESE DRUGS BEFORE YOU CAN BE AUDITED (OR TRAINED).

**ALCOHOL.** DO NOT DRINK ALCOHOLIC BEVERAGES DURING THE 24 HOURS PRECEDING YOUR NEXT AUDITING SESSION. THIS MEANS NO BEER OR WINE AS WELL AS THE STRONGER BEVERAGES.

**SLEEP.** GET ENOUGH SLEEP BEFORE YOUR AUDITING SESSION. YOU SHOULD GET ENOUGH SLEEP TO FEEL WELL-RESTED, NOT JUST ENOUGH TO KEEP GOING.

**EATING.** EAT WELL WHILE BEING PROCESSED. IF YOU HAVE A SESSION IN THE MORNING, EAT A GOOD BREAKFAST. NEVER SKIP A MEAL BEFORE YOUR AUDITING SESSION.

**APPOINTMENTS.** ONCE YOU MAKE AN AUDITING APPOINTMENT, PLEASE KEEP IT AND BE ON TIME.

**UPSETS.** AVOID PERSONS, PLACES, AND SITUATIONS WHICH YOU KNOW WILL UPSET YOU.

**SAFE ENVIRONMENT.** YOUR AUDITOR IS A SAFE PERSON WHO IS INTERESTED IN YOUR WELFARE. DO NOT HESITATE TO ASK OR TELL HIM ANYTHING.

**CONDUCT.** DO NOT DO ANYTHING YOU KNOW IS DISHONEST OR UNLAWFUL.

**OTHER PEOPLE.** IF YOU ARE CONNECTED WITH SOMEONE WHO IS AGAINST YOUR BEING AUDITED OR WHO INVALIDATES YOUR GAINS (OR IF THERE IS SOMEONE FROM WHOM YOU MUST KEEP YOUR AUDITING A SECRET), IT IS ESSENTIAL THAT YOU TELL YOUR AUDITOR ABOUT THIS.

**PHYSICAL HEALTH.** IF YOU HAVE A PHYSICAL PROBLEM OR CONDITION TO BE HANDLED, MAKE THIS KNOWN RIGHT AWAY. YOU MAY BE REQUIRED TO HAVE A MEDICAL EXAMINATION PRIOR TO AUDITING.

**DO NOT DISCUSS YOUR CASE.** IT IS VERY TEMPTING TO TELL YOUR FRIENDS AND RELATIVES ALL THE DETAILS OF YOUR AUDITING SESSION. DON'T, IT WILL NOT HELP YOU (OR THEM) AND IT CAN BE VERY RESTIMULATING.

**YOUR OWN DETERMINISM.** IN ORDER FOR AUDITING TO BE EFFECTIVE, YOU MUST BE HERE ON YOUR OWN DETERMINISM. IF SOMEONE ELSE TALKED YOU INTO AUDITING AND YOU DON'T REALLY WANT IT YOURSELF, TELL THE AUDITOR IMMEDIATELY.

**OTHER PRACTICES.** DO NOT ENGAGE IN OTHER PRACTICES WHILE BEING AUDITED. THIS INCLUDES PSYCHOANALYSIS, PSYCHIATRY, YOGA, HYPNOTISM, MEDITATION, SPIRITUALISM, MYSTICISM, EXTREME DIETING, MARRIAGE COUNSELING, ETC. IF YOU ARE UNDER MEDICAL TREATMENT, DISCUSS THIS WITH YOUR AUDITOR. UNDER SOME CIRCUMSTANCES, AUDITING CAN OCCUR IN CONJUNCTION WITH SUCH TREATMENT.

WHILE IN AN AUDITING SESSION, DO NOT CONFUSE SCIENTOLOGY OR DIANETICS WITH OTHER PRACTICES. DON'T EXPECT THE AUDITOR TO "INTERPRET" FOR YOU OR TELL YOU HOW YOU ARE PROGRESSING. WE DON'T DEAL WITH INK



BLOTS, ANALYSIS, VODOO, OR MYSTICISM. IN SCIENTOLOGY AND DIANETICS IT IS IMPORTANT THAT THE PRECLEAR PARTICIPATE AND UNDERSTAND WHAT IS HAPPENING FOR THE BEST RESULTS TO OCCUR.

UNLIKE OTHER PRACTICES, THE PRECLEAR IS NOT ENCOURAGED TO START TALKING AND RAMBLE ON ABOUT EVERYTHING THAT COMES INTO HIS HEAD. THE AUDITOR USES PRECISE, CONTROLLED, COMMUNICATION. HE ASKS SPECIFICALLY FOR ONE THING AT A TIME. ONE SUBJECT IS FULLY HANDLED BEFORE ANOTHER ONE IS ADDRESSED.

IF YOU SIT IN THE PRECLEAR'S CHAIR WAITING FOR SOME MYSTERIOUS THING TO HAPPEN TO YOU, YOU WILL NOT MAKE PROGRESS. AUDITING IS NOT MYSTERIOUS. YOU CAN AND SHOULD UNDERSTAND WHAT IS HAPPENING. THE AUDITOR DIRECTS, GUIDES, AND LISTENS; BUT IT IS YOU, THE PRECLEAR, WHO DOES THE WORK AND WHO MAKES THE GAINS.

**DO NOT SELF AUDIT.** DON'T TRY TO AUDIT YOURSELF. YOU SHOULD HAVE THE STRENGTH AND GUIDANCE OF A PROFESSIONAL WHEN YOU GO EXPLORING THE REACTIVE MIND.

SOME PEOPLE SELF AUDIT COMPULSIVELY WITHOUT REALIZING IT. WATCH FOR THIS. YOU CAN LOSE YOUR STATE OF RELEASE. DO NOT FINISH A SESSION, THEN GO HOME AND "REVIEW" IT ALL OVER AGAIN. DO NOT ASK YOURSELF QUESTIONS SUCH AS "WHY DO I DO THIS," OR "I WONDER WHAT MAKES ME FEEL THAT WAY..."

GOING BACK OVER A SESSION OR ASKING YOURSELF QUESTIONS ARE BOTH SUBTLE FORMS OF SELF AUDITING, AND THEY CAN CAVE YOU INTO YOUR REACTIVE BANK.

SO, WHEN YOUR SESSION IS FINISHED, END IT. DON'T GO ON SPECULATING, LOOKING, OR INTROVERTING.

GO OUT AND ENJOY THE WORLD AROUND YOU. EXPERIENCE AND UTILIZE THE FULL POWER OF YOUR NEW GAINS.



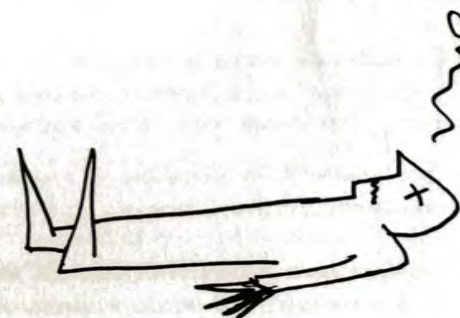

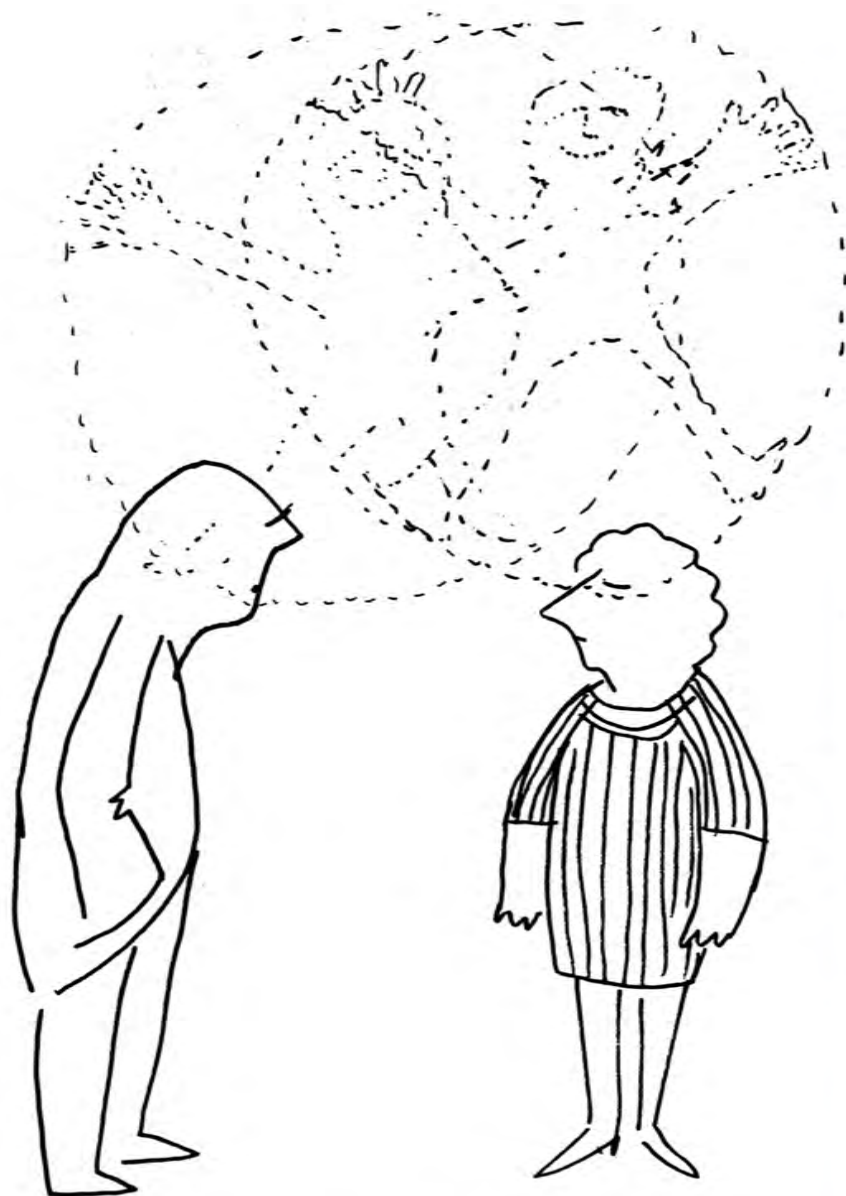

YOU ARE A **SPIRITUAL BEING**, NOT A BODY OR AN ANIMAL, AS YOU WILL DISCOVER IN PROCESSING.

## THE LENGTH OF TIME

WE DO NOT TRY TO PREDICT HOW LONG YOU MUST BE AUDITED TO OBTAIN A PARTICULAR RESULT. IT TAKES AS LONG AS IT TAKES. THERE ARE NO SHORT CUTS TO DOING THE JOB THOROUGHLY WITH STANDARD TECHNOLOGY.

NO MEDALS ARE AWARDED FOR THE FIRST OR THE FASTEST PRECLEAR. THIS IS A FALSE STANDARD. WE WANT TO SEE EACH PRECLEAR ACHIEVE THE GAINS TO WHICH HE IS ENTITLED, NO MATTER HOW LONG IT TAKES.

## USING THE E-METER

AT CERTAIN TIMES IN YOUR PROCESSING, YOUR AUDITOR WILL TELL YOU HE IS GOING TO CHECK SOMETHING ON THE E-METER. (IT MAY BE ONE QUESTION OR A LIST OF THINGS). WHILE HE IS DOING THIS, YOU NEED NOT MAKE VERBAL COMMENTS. JUST HOLD THE CANS WHILE HE LOOKS FOR THE E-METER RESPONSES.

## REVIEW

SHOULD THERE BE A TIME WHEN STANDARD PROCESSES ARE NOT RUNNING SMOOTHLY OR YOU ARE NOT MAKING GAINS, YOU WILL RECEIVE AN AUDITING REVIEW TO CORRECT WHATEVER MAY BE STOPPING YOUR PROGRESS.

THIS IS AN ADDITIONAL FUNCTION, SEPARATE FROM YOUR AUDITING INTENSIVE. IN MOST CASES, YOU WILL BE ABLE TO RESUME YOUR AUDITING INTENSIVE ONCE THE REVIEW IS FINISHED.

## THE AUDITOR'S CODE

SO THAT YOU MAY UNDERSTAND THE ETHICAL STANDARDS UNDER WHICH YOUR AUDITOR OPERATES, WE HAVE INCLUDED THE AUDITOR'S CODE ON THE FOLLOWING PAGES.



# The Auditor's Code

- (1) I PROMISE NOT TO EVALUATE FOR THE PRECLEAR OR TELL HIM WHAT HE SHOULD THINK ABOUT HIS CASE IN SESSION.
- (2) I PROMISE NOT TO INVALIDATE THE PRECLEAR'S CASE OR GAINS IN OR OUT OF SESSION.
- (3) I PROMISE TO ADMINISTER ONLY STANDARD TECH TO A PRECLEAR IN THE STANDARD WAY.
- (4) I PROMISE TO KEEP ALL AUDITING APPOINTMENTS ONCE MADE.
- (5) I PROMISE NOT TO PROCESS A PRECLEAR WHO HAS NOT HAD SUFFICIENT REST AND WHO IS PHYSICALLY TIRED.
- (6) I PROMISE NOT TO PROCESS A PRECLEAR WHO IS IMPROPERLY FED OR HUNGRY.
- (7) I PROMISE NOT TO PERMIT A FREQUENT CHANGE OF AUDITORS.
- (8) I PROMISE NOT TO SYMPATHIZE WITH A PRECLEAR, BUT BE EFFECTIVE.
- (9) I PROMISE NOT TO LET THE PRECLEAR END SESSION ON HIS OWN DETERMINISM, BUT TO FINISH OFF THOSE CYCLES I HAVE BEGUN.
- (10) I PROMISE NEVER TO WALK OFF FROM A PRECLEAR IN SESSION.
- (11) I PROMISE NEVER TO GET ANGRY WITH A PRECLEAR IN SESSION.
- (12) I PROMISE TO RUN EVERY MAJOR CASE ACTION TO A FLOATING NEEDLE.
- (13) I PROMISE NEVER TO RUN ANY ONE ACTION BEYOND ITS FLOATING NEEDLE.
- (14) I PROMISE TO GRANT BEINGNESS TO THE PRECLEAR IN SESSION.
- (15) I PROMISE NOT TO MIX THE PROCESSES OF SCIENTOLOGY WITH OTHER PRACTICES EXCEPT WHEN THE PRECLEAR IS PHYSICALLY ILL AND ONLY MEDICAL MEANS WILL SERVE.
- (16) I PROMISE TO MAINTAIN COMMUNICATION WITH THE PRECLEAR AND NOT TO CUT HIS COMM OR PERMIT HIM TO OVERRUN IN SESSION.

- (17) I PROMISE NOT TO ENTER COMMENTS, EXPRESSIONS OR ENTURBULENCE INTO A SESSION THAT DISTRACT A PRECLEAR FROM HIS CASE.
- (18) I PROMISE TO CONTINUE TO GIVE THE PRECLEAR THE PROCESS OR AUDITING COMMAND WHEN NEEDED IN THE SESSION.
- (19) I PROMISE NOT TO LET A PRECLEAR RUN A WRONGLY UNDERSTOOD COMMAND.
- (20) I PROMISE NOT TO EXPLAIN, JUSTIFY OR MAKE EXCUSES IN SESSION FOR ANY AUDITOR MISTAKES WHETHER REAL OR IMAGINED.
- (21) I PROMISE TO ESTIMATE THE CURRENT CASE STATE OF A PRECLEAR ONLY BY STANDARD CASE SUPERVISION DATA AND NOT TO DIVERGE BECAUSE OF SOME IMAGINED DIFFERENCE IN THE CASE.
- (22) I PROMISE NEVER TO USE THE SECRETS OF A PRECLEAR DIVULGED IN SESSION FOR PUNISHMENT OR PERSONAL GAIN.
- (23) I PROMISE TO SEE THAT ANY FEE RECEIVED FOR PROCESSING IS REFUNDED IF THE PRECLEAR IS DISSATISFIED AND DEMANDS IT WITHIN THREE MONTHS AFTER THE PROCESSING, THE ONLY CONDITION BEING THAT HE MAY NOT AGAIN BE PROCESSED OR TRAINED.
- (24) I PROMISE NOT TO ADVOCATE SCIENTOLOGY ONLY TO CURE ILLNESS OR ONLY TO TREAT THE INSANE, KNOWING WELL IT WAS INTENDED FOR SPIRITUAL GAIN.
- (25) I PROMISE TO CO-OPERATE FULLY WITH THE LEGAL ORGANIZATIONS OF DIANETICS AND SCIENTOLOGY AS DEVELOPED BY L. RON HUBBARD IN SAFEGUARDING THE ETHICAL USE AND PRACTICE OF THE SUBJECT ACCORDING TO THE BASICS OF STANDARD TECH.
- (26) I PROMISE TO REFUSE TO PERMIT ANY BEING TO BE PHYSICALLY INJURED, VIOLENTLY DAMAGED, OPERATED ON OR KILLED IN THE NAME OF "MENTAL TREATMENT."
- (27) I PROMISE NOT TO PERMIT SEXUAL LIBERTIES OR VIOLATION OF THE MENTALLY UNSOUND.
- (28) I PROMISE TO REFUSE TO ADMIT TO THE RANKS OF PRACTITIONERS ANY BEING WHO IS INSANE.

<b>OT VII</b>	ONE CONFRONTS THE MECHANICS OF THOUGHT ITSELF AND TAKES THE FINAL STEP ON THE ROAD TO COMPLETE SELF-KNOWLEDGE.
<b>OT VI</b>	THE RECOVERY OF ONE'S FORMER ABILITY TO BE WHERE ONE WANTS TO BE AT WILL.
<b>OT V</b>	ONE LOOKS AT BASICS FAR ABOVE PHYSICS, AND LEARNS TO CONFRONT THE PHYSICAL UNIVERSE AND UNDERSTAND HIS RELATIONSHIP TO IT.
<b>OT IV</b>	THE FINAL POLISH AND REVIEW OF PRE-OT'S CASE, IT LEAVES ONE CLEAN, REACHING TO FACE HIGHER STATES OF BEINGNESS.
<b>OT III</b>	THIS IS THE "WALL OF FIRE" MENTIONED ON RON'S JOURNAL '67--THE GREAT CATASTROPHE WHICH OCCURRED ON THIS PLANET 75 MILLION YEARS AGO. OT III IS THE FULL REVELATION OF WHAT HAPPENED AND ITS RESOLUTION. THE BARRIERS THAT OBSCURE THE ULTIMATE TRUTH OF THE UNIVERSE ARE BLOWN.
<b>OT II</b>	THE POWER AND ABILITY NECESSARY TO CONFRONT THE MATERIALS OF OT III.
<b>OT I</b>	BARRIERS ON OTHER DYNAMICS START TO BLOW AND NEW HORIZONS ARE OPENED.
<b>CLEAR</b>	ABILITY TO BE AT CAUSE OVER MENTAL MATTER, ENERGY, SPACE AND TIME, ON THE 1ST DYNAMIC (SURVIVAL FOR SELF).
<b>GRADE VI</b>	<u>WHOLE TRACK RELEASE</u> . RETURN OF POWERS TO ACT ON OWN DETERMINISM--FREEDOM FROM DRAMATIZATION.
<b>GRADE V &amp; VA</b>	<u>POWER AND POWER PLUS RELEASE</u> . RELEASE FROM WHOLE TRACK ENGRAMS. ABILITY TO HANDLE POWER.
<b>GRADE IV</b>	<u>ABILITY RELEASE</u> . MOVING OUT OF FIXED CONDITION AND GAINING ABILITIES TO DO NEW THINGS.
<b>GRADE III</b>	<u>FREEDOM RELEASE</u> . FREEDOM FROM THE UPSETS OF THE PAST AND ABILITY TO FACE THE FUTURE.
<b>GRADE II</b>	<u>RELIEF RELEASE</u> . RELIEF FROM HOSTILITIES AND SUFFERINGS OF LIFE.
<b>GRADE I</b>	<u>PROBLEMS RELEASE</u> . ABILITY TO RECOGNIZE SOURCE OF PROBLEMS AND MAKE THEM VANISH.
<b>GRADE 0</b>	<u>COMMUNICATIONS RELEASE</u> . ABILITY TO COMMUNICATE FREELY WITH ANYONE ON ANY SUBJECT.
<b>DIANETICS</b>	A WELL AND HAPPY HUMAN BEING; ERASURE OF ALL LOCKS, SECONDARIES, AND ENGRAMS THAT ARE RESULTING IN UNDESIRABLE PHYSICAL CONDITIONS.

## SCIENTOLOGY AUDITING

AFTER DIANETICS AUDITING YOU WILL BE READY TO BEGIN THE PROCESSES OF SCIENTOLOGY. THESE ARE QUITE DIFFERENT.

DIANETICS PROCESSING ERASES INCIDENTS RELATED TO THE BODY. SCIENTOLOGY PROCESSES ADDRESS THE SPIRITUAL BEING, AND RELEASE HIM UP THE GRADES (AS SHOWN ON THE GRADATION CHART).

**RUDIMENTS.** AT THE BEGINNING OF EACH SCIENTOLOGY SESSION, THE AUDITOR WILL ASK YOU A SERIES OF QUESTIONS, CHECKING THEM ON THE METER. THESE QUESTIONS ARE CALLED "RUDIMENTS," AND ARE USED TO CLEAN UP ANY CURRENT SITUATIONS WHICH MIGHT BE DISTURBING YOU ENOUGH TO INTERFERE WITH THE PROCESSING.

**REPETITIVE COMMANDS.** SOME OF THE SCIENTOLOGY PROCESSES CONSIST OF REPETITIVE COMMANDS. THAT IS, THE SAME COMMAND IS GIVEN MANY TIMES. THIS DOES NOT MEAN THAT THE AUDITOR IS UNWILLING TO ACCEPT YOUR FIRST ANSWER (OR ANY OTHERS). HE WANTS TO GET EVERY AVAILABLE ANSWER NECESSARY TO PRODUCE A FLOATING NEEDLE ON THE PROCESS.

## RELEASE

WHEN A PERSON IS RELEASED, HE IS SEPARATED FROM THE REACTIVE MIND OR SOME PORTION OF IT; IT HAS NO INFLUENCE OVER HIM AT THAT TIME.

THIS STATE IS MANIFESTED ON THE E-METER BY WHAT WE CALL A "FLOATING NEEDLE." AT THE SAME TIME, THE PRECLEAR MAY HAVE A REALIZATION ABOUT SOMETHING (WE CALL THIS A "COGNITION"). IN ANY CASE, THE PRECLEAR WILL FEEL COMPLETELY UNTRoubLED AND HE WILL LOOK BRIGHT AND HAPPY.



WHEN THE AUDITOR SEES A FLOATING NEEDLE ON HIS E-METER, HE WILL INDICATE IT TO YOU AND CEASE ADDRESSING THE PARTICULAR INCIDENT (OR SUBJECT) BEING RUN.

WHEN RELEASE OCCURS, THE AUDITOR MAY GO ON TO THE NEXT ACTION OF YOUR PROCESSING, OR HE MAY END THE SESSION BY SAYING "THAT'S IT."

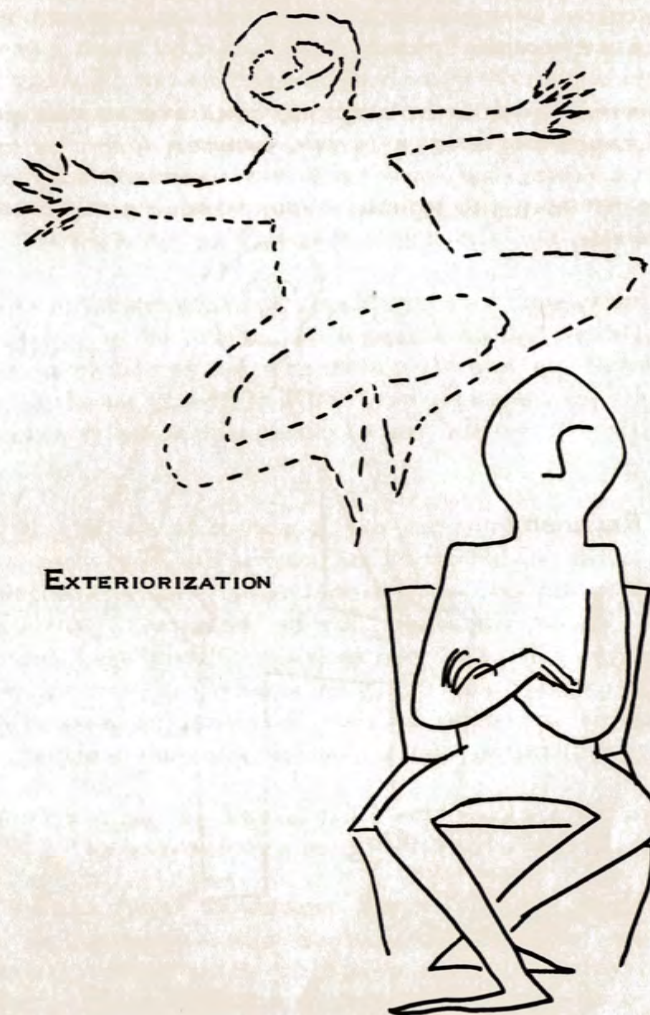
THE ENTIRE PROGRAM OF AUDITING CONSISTS OF A SERIES OF RELEASES AS, STEP BY STEP, VARIOUS PARTS OF THE REACTIVE MIND ARE ADDRESSED AND HANDLED. YOU CAN EXPECT TO HEAR THE WORDS, "YOUR NEEDLE'S FLOATING" VERY OFTEN.



### EXTERIORIZATION

EXTERIORIZATION IS THE STATE OF THE THETAN BEING OUTSIDE OF HIS BODY. WHEN THIS OCCURS, THE PERSON ACHIEVES A CERTAINTY THAT HE IS HIMSELF AND NOT HIS

BODY. COMPULSIVE EXTERIORIZATION MAY OCCUR WHEN THE BODY IS THREATENED (DURING AN ACCIDENT, ILLNESS, OPERATION, OR DRUG TRIP). HOWEVER, A PERSON CAN EXTERIORIZE NATURALLY, AND THIS SOMETIMES HAPPENS IN SESSION ON THE HIGHER GRADES OF SCIENTOLOGY.



THIS PHENOMENON IS NOT THE SAME AS RELEASE (BEING EXTERIOR TO THOUGHTS AND DRAMATIZATIONS OF THE REACTIVE MIND). ONE IS ACTUALLY EXTERIOR TO HIS BODY, AND KNOWS HE IS OUTSIDE OF HIS BODY.



## GAINS

YOUR DIANETIC AUDITING ERASES LOCKS, SECONDARIES, AND ENGRAMS WHICH ARE CAUSING UNWANTED EMOTIONS AND PHYSICAL DIFFICULTIES. DIANETIC AUDITING IS DONE UNTIL THE PRECLEAR'S BODY IS PHYSICALLY WELL AND HE IS HAPPY WITH IT. ONCE THE SOURCE OF AN AILMENT IS FOUND AND ERASED, THE PRECLEAR WILL NOT HAVE A RELAPSE; THE IMPROVEMENT IS PERMANENT.

THE STATE OF RELEASE (OBTAINED THROUGH THE GRADES OF SCIENTOLOGY AUDITING), MAY NOT BE PERMANENT.

WHEN RELEASED, THE PRECLEAR IS KEYED-OUT (OR SEPARATED) FROM HIS REACTIVE MIND. UNTIL HE IS CLEAR, A PERSON CAN BE RESTIMULATED (OR KEYED-IN) BY SOMETHING IN HIS ENVIRONMENT. THIS DOES NOT MEAN, HOWEVER, THAT HE LOSES THE GAINS HE HAS MADE IN AUDITING.

WHILE THE ENVIRONMENT CAN SOMETIMES BE RESTIMULATING, THE MAIN CAUSE OF KEY-IN IS THE PRECLEAR HIMSELF DOING ONE OF THE FOLLOWING: SELF-AUDITING, TALKING ABOUT HIS CASE OUT OF SESSION, ACTUALLY PREDICTING THE LOSS OF RELEASE ("THIS WILL NEVER LAST,") PLANNING AN ATTACK ON SOMETHING, PROTESTING, WANTING TO GET EVEN OR GET REVENGE, OR ASSERTING HIS OWN RIGHTNESS WHILE MAKING ANOTHER WRONG.

KNOWING THIS DATA, YOU MAY OFTEN BE ABLE TO PREVENT THE SITUATIONS WHICH COULD CAUSE KEY-IN.

IN ANY CASE, DO NOT BE TOO CONCERNED ABOUT LOSING A STATE OF RELEASE; IT CAN BE REHABILITATED BY A TRAINED AUDITOR. EACH GRADE OF SCIENTOLOGY AUDITING IS A VITAL STEP CLOSER TO THE STATE OF CLEAR. KEEP GOING ON YOUR TRAINING AND AUDITING. EACH RELEASE TAKES SOME OF THE POWER OUT OF THE REACTIVE MIND AND GIVES IT TO YOU. YOU WILL MAKE STEADY AND LASTING GAINS.

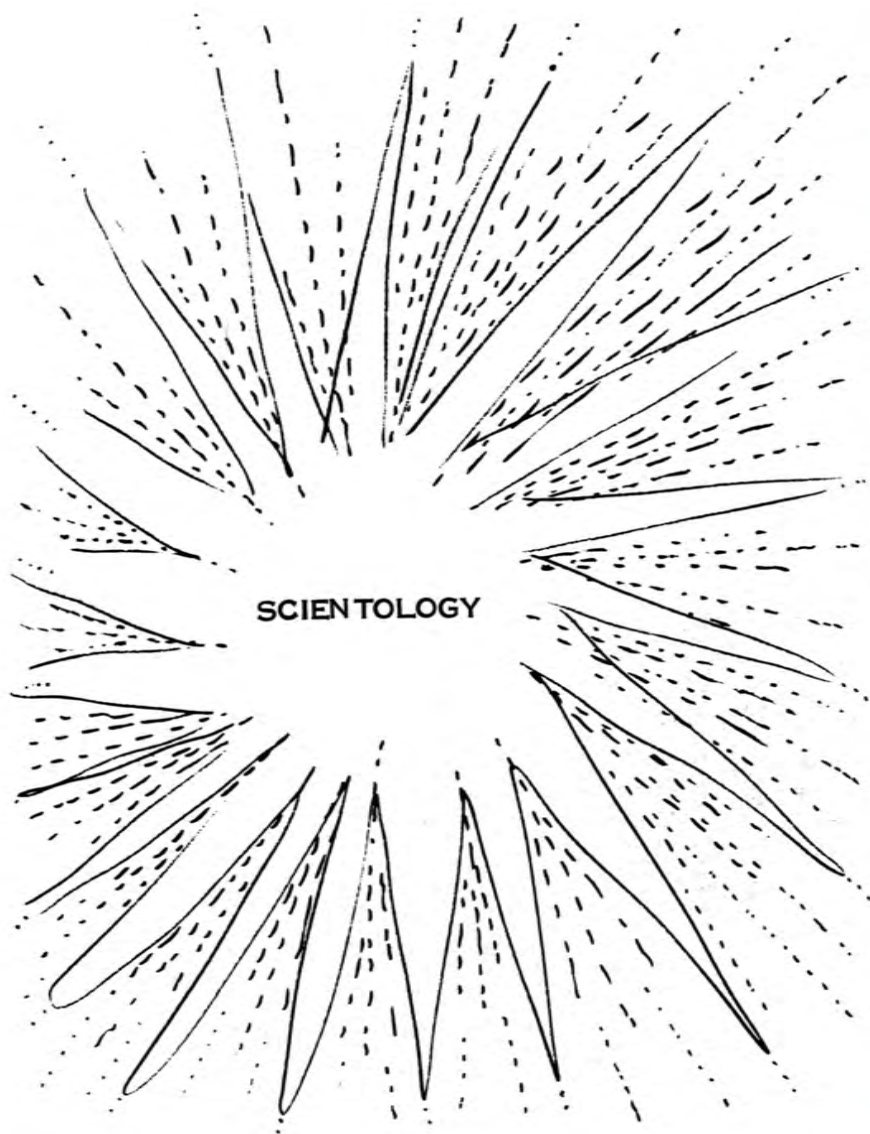
